Shelf Life: 2 years in original unopened container

Storage Conditions: 40°F-95°F (5°C-5°C)

APPLICATION

Apply directly from container by spraying in a cross hatch pattern to form a uniform, continuous film. Prior to coating plywood forms, apply one or two heavy brush coats to edges to ensure complete water-proofing protection.

COVERAGE

Steel/aluminum/HDO: 1,500—2,000 sq. ft./gal.

Medium density plywood: 500-1,000 sq. ft./gal.

BB grade plywood: 750 sq. ft./gal.

Rough-sawn lumber, striated plywood:

1st coat—500 sq. ft./gal.

Subsequent uses: 1,000 sq. ft./gal.

LIMITATIONS

When any coating material is to be applied over the newly formed concrete, follow the application instructions of the material manufacturer.
